Treasurer's report

Issue: Our current bank account at the Florence Bank uses the Lathrop Community's tax identification number. This must change as this account is separate from the Lathrop Community and therefore the Lathrop Community does not oversee dispersal of these funds. In order for the Residents 'Association to open a new bank account the Council must approve the Residents Association becoming a 501(c)7. (social club designation) The motion was made to approve this designation and to approve these officers for the newly established Lathrop Northampton Residents 'Association: President: Elizabeth Rumelt, Vice President: Cornelia Claire Frierson; Secretary, Judith Hyde; Treasurer, Jean Shackelford. Motions carried.

Minutes policy change

In a change to our usual procedure, now the officers will approve minutes ASAP after each meeting of the Council, and the minutes will be distributed to all Residents. Any corrections from others will be presented at the next meeting. This resulted today in a correction to the September minutes from Goldenchain regarding mounting a small flag pole on the porch. This was not a consensus in the Goldenchain lane meeting, but a suggestion by one person.

Crosswalk signs

Crabapple would like a crosswalk at the end of their lane. Aspen would like one to the garden. General feeling that the signs have been effective but not 100% for Goldenchain and Hawthorn

lanes. Cindy is going to be replacing 15 mph signs because she thinks they are too small. We can ask for another one.

Flag

A Goldenchain conversation brought out feelings about what it means to be a citizen of this country. Perhaps we might have a group discussion. Claire mentioned an amusing film, What the Constitution Means to Me, that could get us going. Marlisa endorsed it as very good. Volunteers sought for a committee to decide on procedure for display of a flag on a mount on the porch railing (similar to the one for the mail flag). Virginia has volunteered, along with Ginny.Sally offered info supporting the idea that a flag can be displayed permanently if the lighting is sufficient. Is this a matter for the Council or the Association? Elly said that such a matter is brought to the lanes and then comments reviewed by the Council which sets policy.

Patio

The new patio is now complete. Funds applied for from the pandemic relief fund from Northampton for a permanent covering and the electric work. No fund raising by us needed now. Also seeking funds for internet improvement. Frustration expressed about the unreliability of the Meeting House connectivity. This meeting, for example, was not on Zoom due to technical difficulties.

Lane concerns

Hawthorn: Request for an organization chart. Can anything be done about gun noise? An old quarry is used for target practice. This is being investigated.

Facilities: There is a dead tree near the trail. The safety committee looked at it, says that the tree isn't at risk of coming down. When will moss be removed from roofs? Is there a plan for repainting or removing furniture? Not enough light on Hawthorn. When will LED lighting be installed? Freeze last night. Water needs to be turned off. Chris Hague said they don't need to be turned off. Hoses need to be removed though.

Firethorn: Flower bed at Shallowbrook entrance looking bad.

Committee reports

Land -Dale

Linden trees have been planted in the vacant lot by the community garden. We are going to do an inventory of plants residents can offer us for this area.

Bittersweet removal is underway by residents. Barbara Walvoord is coming 2 pm Saturday to meet with residents about bittersweet removal.

Will be meeting monthly. Need new members.

Tai Chi and Yoga classes now happening

Safety - Virginia

Thanks to Chris Hague for signs.

The dead tree near the trail was viewed and felt that it was not a hazard as it was not about to fall. The lack of a safe way to cross Shallowbrook from Aspen to get to the dog park and the community garden remains an issue. It is not clear how to improve safety there, since it is too close to the turnoff from Bridge to put a crosswalk there. The Safety Committee will explore possibilities. Sidewalk? Would ruin landscaping.

Is lighting on Hawthorn a safety issue? A filter keeps it from shining in a window of someone who doesn't like it shining in, but makes the lighting dim. Will be brought up at next meeting. Also the light out on Goldenchain needs repair by an electrician.

Music- Jeff

Fourteen events now scheduled through next June. Dave raised a question about the acoustics of the room since the fabric curtains were removed. Seems to be good for musicians,.

Meeting house planning - Dave

Plan to check roof, moss. Thin plantings at entry door.

Board - Marlisa

Very gifted board. Now will meet every other month. The last meeting featured a focus session on values like the ones held for residents as part of preparation for the strategic planning retreat. How do we develop a culture of bringing out the best? What are the preferences of consumers of residential communities for seniors now? Liz Weissbach was invited to join the Board.
